#### **Application Process**

Application Instructions	The Incoming Exchange Application form <u>and</u> all supporting documents must be <u>submitted online</u> . Eligible students will be provided with detailed application instructions and the application link.
Supporting Documents to be Included with Application Form	<ul> <li>Official proof of English proficiency (TOEFL, IELTS, or CAEL, PTE Academic). The test report must be in English and the test date cannot be more than 24 months prior to application</li> <li>Most recent official transcript translated into English with the Home Institution's Grading System</li> <li>In order of priority, a list of ten (10) Carleton courses the student would like to be registered in, including course titles and course codes.</li> <li>Portfolios must be included for students applying for courses in Architecture, Industrial Design and Interactive Multimedia Design (IMD)</li> <li>An audition is required for performance courses in Music</li> </ul>

Course Selection:	Course availability is subject to change and for this reason we <b>cannot</b>
	guarantee registration in specific courses. For exchange term(s) at Carleton,
	students should create a study plan that includes a mixture of courses from
	their major, minor, concentration and most especially free electives.
	The courses listed on an Incoming Exchange Application form will be reviewed
	by Carleton's departmental advisors. If courses have been selected from more
	than one discipline, a request will be sent to the designated department
	contact for each discipline.
	Our academic departments will determine which courses an exchange
	student is approved to take. Each department has their own criteria when
	assessing course requests, the most important of which is whether a student
	has the required academic background to meet the course prerequisites.

	<ul> <li><b>REMINDERS:</b> 1) A student may not be approved to take all of the courses they have requested on their application. This can be due to a number of factors, including but not limited to: course is restricted and not open to exchange students, course is full, course is not offered in correct exchange term, course is cancelled, course conflicts with other registered courses or the student does not meet the academic prerequisites to take the course.</li> <li>2) Students requesting <b>full year courses</b> must be prepared to complete both terms of the course (i.e. Fall 2023 <u>and</u> Winter 2024) in order to receive academic credit for the course. This applies even if the course is offered online.</li> </ul>

#### Visa Requirements

If your studies in Canada will be <u>less than 6 months in duration</u>, you may study as a visitor without having a study permit.

Most international students need a Temporary Resident Visa (TRV) *or* Electronic Travel Authorization (eTA) to travel to Canada. <u>The Immigration, Refugees and Citizenship Canada website</u> has a tool to help you determine which you need and lead you to the correct online application. This letter may be used in a TRV application to explain the purpose of your visit to Canada.

If you plan to study in Canada for <u>more than 6 months</u>, you must apply for a study permit. Your application for a study permit is automatically your application for a TRV or eTA as well.

The <u>ISSO's website</u> tells you how to start the online study permit application process and provides helpful tips. Requirements for the application vary by country, but all students will need a valid passport, a Carleton Letter of Acceptance (this letter), and proof of having sufficient resources to cover expenses in Canada. You will probably have to give <u>biometrics</u>, and may need to get a medical exam and/or police certificate(s). You should gather your documents and submit your application as soon as possible.
