



## Frequently Asked Questions (FAQS)

#### 1. Where will we be going for our one semester & Global?

One Semester Students & Global will be going to any of our partner university (Refer to page no. 16 for reference)

More partners will be offered in case of availability of exchange.

2. For How Long?

One Semester Students will be going for 5.5 months Two Semester abroad students for 11.5 months.

3. When will we be going?

First exchange will happen Between August 25th to January 26th of next year, two Semesters additionally will go from March 10th to October 10th of their final year (Depending on the foreign partner).

4. What is the Living Expenses?

Euros 800 per month i.e. boarding lodging and local travel (Approximate figure quoted keeping in mind inflation).

5. What is the Travelling Expenses?

As per current prices. Ticket prices are dynamic. Accommodation will be about Euros 350 (Approximate figure quoted keeping in mind inflation). Rest will be food and local commute.

6. Will there be any other cost?

Yes, Visa cost plus travel insurance.

7. Can I work?

When you are on a student visa you cannot work.

8. How about internship?

The exchange is only for 6 months and the university work load will be challenging enough.

## Frequently Asked Questions (FAQS)

#### 9. Can I volunteer?

Yes, at the Research Department they will always have a need for a research assistant. You can volunteer to do data mining or data analysis if that is your forte and you can ask for a certificate at the end of the term.

10. How will this help me?

Study abroad in a multi-cultural, multi ethnic, multi-national environment is a key skill which is required for future managers. It helps you see the world and develop a global mind set

11. How will we apply?

Nomination - International Relations Office from ISBR will nominate you

The Partner university will then contact you via email and send you a link to upload your application on their portal.Once you submit the application giving all your details and accommodation preferences we have to wait for their response.Your application may be accepted, or it may be rejected. If one school rejects you we will apply to another school. It's a privilege and not an entitlement to go to these schools.Once you are accepted they will send you an Invitation letter.ISBR will issue to you a Bonafide certificate and No Objection Certificate.You will do the Visa Process for Travelling to France (ISBR will guide you).You will attend the visa interview and state your purpose of visit as education for a semester and return to India to continue your education at ISBR. By now you ought to have and booked your tickets for travel (2 way ticket) Undertake the Travel.

12. What are the living arrangements in France?

University will allot you an accommodation partner

University will put you in touch with the accommodation provider You need to inform them about your arrival and departure dates.

Depending upon the city anywhere up to 800 Euros a month (Approximate figur quoted keeping in mind inflation ).

15. How many subjects do I have to study?

The same number you would have studied in ISBR.

16. Are Credits Transferrable?

Yes

17. Will I have to write additional Exams in ISBR?

No. If you pass all your courses in partner university then your transcript will be send by partner University to ISBR & the same will be uploaded in their portal as well. The partner university transcript will be considered for accessing the passing criteria of the students and accordingly Indian (ISBR) marksheet and degree will be generated for the students.

18. Do recruiters in India value this?

Yes and it depends on what course work you have done and how you are able to highlight it in your resume.

19. Can I get employment abroad?

All of these schools offer you additional courses which you can inquire and if any of it suits you may after your PGDM decide to do it.

20.What else Must I know ?

Buy a Sim Card to keep in touch with everyone Carry all identification documents Open a bank account there the moment you settle in.
