### APPLICATION PROCESS

Information	<p><b>This application process applies only to exchange students attending modules for one teaching block or full year.</b> Please note that students attending only for thesis preparation/research project, need to complete a different application form. Students should contact <a href="mailto:exchange-admissions@port.ac.uk">exchange-admissions@port.ac.uk</a> to receive further guidance in this instance.</p> <p>Applications to the exchange programme can <b>only</b> be made via an online application portal; access to which will be provided to every accepted nomination by email, along with an application guide. Nominators will also be included in this email.</p> <p>Students must receive and accept a conditional offer from the University before accommodation can be applied for. Students need an unconditional offer to secure housing. <b>As such it is strongly recommended that students complete their applications at the earliest opportunity to secure housing.</b></p> <p><b>Please note that applications received after the given deadline may not be accepted!</b></p>

<b>Academic Requirements</b>	<p>Each nominated student must have successfully completed <b>at least one year</b> of academic study at their home institution and meet the following entry requirements:</p> <ol style="list-style-type: none"> <li>1) A copy of their official transcript of records, stamped and signed and in English</li> <li>2) English language proficiency evidence at a minimum of IELTS band 6.0 with no component score below 5.5 or an approved equivalent. See <i>Language Requirements</i> section for more information.</li> <li>3) A copy of a valid passport</li> <li>4) Learning Agreement including a list of selected modules</li> <li>5) Portfolio of your work (<u>ONLY for students joining the Exchange Programme in the Faculty of Creative and Cultural Industries</u>).</li> </ol>
<b>Learning Agreement for Studies</b>	<p>The <b>Learning Agreement for Studies</b> must show all modules selected for the intended period of mobility. The Learning Agreement <b>must be signed by the student and home Academic Coordinator, and then submitted before the start of the mobility</b>. We advise students to submit their Learning Agreement for Studies as soon as possible to ensure module availability.</p>

## PRACTICAL INFORMATION

<b>Visa</b>	<p>All students applying to study on an Exchange or Study Abroad Programme, need to apply for the correct visa to study in the UK, depending on the mobility duration:</p> <p><b>VISAS FOR 6 MONTHS OR LESS</b></p> <p>If the exchange programme lasts for 6 months or less, students will need to apply for visa from the '<a href="#">Standard Visitor for the purpose of study</a>' category. The 'Standard Visitor for the purpose of Study' visa <b>can't be extended</b> and applicants <b>aren't permitted to work on this visa</b>. Students cannot switch to the Student Route visa in the UK if they have entered as a Standard Visitor. They must apply in their home country. A Student Route visa for an Exchange programme cannot be extended in the UK. <b>ATAS Check</b>	<p><b>Academic Technology Approval Scheme (ATAS)</b> – To study some of our courses in <u>science and technology</u>, students need to have clearance under ATAS. This will be requested depending on the modules selected to study. ATAS is a security check the UK Foreign and Commonwealth Office makes. <b>Language Requirements</b>	<p>Language of instruction: <b>English</b></p> <p><b>ALL APPLICANTS</b> must provide evidence of their English language proficiency at a minimum of IELTS band 6.0 with no component score below 5.5 or an approved equivalent - please see a <b>full list of accepted English language tests</b> on our website:</p>

<b>Transcript of Records</b>	All students who complete their exchange with us will receive their official transcript in the following July after the Board of Examiners concludes.

<b>Healthcare and insurance</b>	<p>Students applying for the UKVI Student Route for a visa duration of <u>six months or more</u>, are required to pay the Immigration Health Surcharge (IHS) as a compulsory part of a visa application. This will give them access to NHS healthcare and the ability to register with a GP (doctor).</p> <p>Students applying for less than six months, and for a Standard Visitor visa for the purpose of study, can still access medical care, but they will be required to pay for the service. Students may be able to register as a temporary patient with a GP surgery and may be able to access National Health Service (NHS) walk-in services.</p> <p>It is strongly recommended that all students obtain comprehensive travel and medical insurance with sickness cover before arriving in the UK to cover the period of stay. <b>Accommodation (Student Housing team)</b>	<p>A room can be offered in halls for all students, applying for full year or autumn term, who accept their offer to the University of Portsmouth and meet any accommodation deadlines and other related requirements. Accommodation in halls of residence is dependent upon availability. Exchange students can apply for accommodation once a conditional offer has been made to them. Therefore, it is strongly recommended that students complete their application form early, so there is adequate time for applying for accommodation and to meet relevant deadlines. Housing will only be confirmed once an Unconditional offer is made.</p> <p>The Student Housing team will assist students in finding a place to live either in a Hall of Residence or a student house in the private sector. There is a variety of private accommodation in Portsmouth, with a range of price points.</p> <p>Accommodation applications will be sent by email by the end of March 2026 (for September 2026 intake), and October 2026 (for January 2027 intake) to all students who have firmly accepted an offer to study here for 2026/27. Places in halls of residence are allocated in order of receipt of the accommodation application in Student Housing. Applicants will be allocated to their highest available preference of accommodation, subject to availability.</p> <p>Students, who have received an official acceptance from the university and applied for halls of residence, will be notified from April onward of the outcome of their application. If allocated to halls, a £250 deposit or advanced rent will be required within 2 weeks of receiving a room offer to secure the room (refundable, if cancelled by set deadline).
