

2.2 English language requirements

In order to undertake an exchange programme at the University, exchange students and Study Abroad students will need to demonstrate a suitable level of English proficiency.

To assess the student's English language level we will look at the following:

- If the Nationality of the student is from a recognised English Speaking Country, no proof of English language proficiency is required (UKVI exempt list). Full list of UKVI English Speaking countries is available on our website. Canadian Nationals are an exception and do not need a proof of English.
- If the institution is from a country outside this list, and outside the EU, the student must provide an Approved English test if they are applying for a T4 visa
- If a non-EU national applies for a Short Term Study Visa (STSV) and his/her Nationality is from a country outside the English Speaking Country (UKVI list), the student will need to provide an Approved English test even if they are studying at a current partner in English.
- When the student has an EU Nationality and is from one of our European partners, (no VISA required) we will look at the English level achieved by the student at the end of his/her secondary education, and request a specific grade as indicated in the table below per country (eg. A French student must have achieved 14/20 in English at the French Baccaureat as this is deemed to be equivalent to a B2 level of English). A full list of qualifications for each country partner is available in the table below.
- Should the student not have an English grade as part of his/her end of secondary education qualification, or have failed the requested grade, we can also accept an official Certificate produced by the home institution and signed by the student's academic tutor, certifying that the student's standard of English language is high and **at least equivalent to B2 level** based on the Common European Framework of Reference for Languages. This Certificate must be produced on the home institution letterhead paper—and uploaded with the application. This acceptance flexibility is only acceptable for EU Nationals.
- As part of the nomination process, the institution will confirm the English level of the student on the nomination form.
